## NOTICE OF REFERENDUM \$90,000,000 GENERAL OBLIGATION BONDS THE CONSOLIDATED SCHOOL DISTRICT OF AIKEN COUNTY, SOUTH CAROLINA

NOTICE IS HEREBY GIVEN that a referendum will be held in The School District of Aiken County, South Carolina (the "School District"), on May 1, 2018, for the purpose of submitting to all persons qualified to vote in the School District, under the Constitution and laws of the State of South Carolina, the following question:

Shall the Board of Education of The Consolidated School District of Aiken County, South Carolina (the "School District") be empowered to issue, at one time or from time to time, general obligation bonds of the School District, in a principal amount of not exceeding \$90,000,000, the proceeds of which shall be used to finance the costs (including architectural, engineering, legal and related fees) of acquiring, constructing, improving, equipping, expanding, renovating, and repairing school facilities, including land acquisition, if necessary, within the School District, as follows:

Renovation and Expansion of existing facilities: Midland Valley High School Hammond Hill Elementary School Belvedere Elementary School Millbrook Elementary School

Constructing and equipping new facilities:

A new elementary school and a new middle school sharing a common campus site location and sharing the utilization of certain common facilities as may be practicable, to be located between Graniteville and North Augusta?

If the voter wishes to vote in favor of the question, fill in the oval next to "In favor of the question;" if the voter wishes to vote against the question, fill in the oval next to the words, "Opposed to the question."

Using a blue or black ballpoint pen to mark the paper Absentee Ballot or on the iVotronic touch the box by your selection: If the voter wishes to vote in favor of the question, fill in the oval next to "In favor of the question / yes"; if the voter wishes to vote against the question, fill in the oval next to "Opposed to the question / no".

Such question is being submitted pursuant to Article X, Section 15 of the Constitution of the State of South Carolina, 1895, as amended, Title 11, Chapter 27, Code of Laws of the State of South Carolina 1976, as amended, and Title 59, Chapter 71, Article 1, Code of Laws of South Carolina, 1976, as amended. If a majority of the qualified electors of the School District voting in the Referendum approve the issuance of not exceeding \$90,000,000 General Obligation Bonds (the "Bonds"), the Bonds may be issued by the School District either as a single issue or from time to time as several separate issues, but no Bonds shall be issued later than five years from the date of the Referendum. The proceeds of the Bonds will be used to construct, improve, equip and renovate school buildings or other school facilities, including land acquisition.

Voters will be asked to provide one of the following Photo IDs:

- S.C. Driver's License
- ID Card issued by S.C. Department of Motor Vehicles
- S.C. Voter Registration Card with Photo
- Federal Military ID
- U.S. Passport

If you have one of these IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county election commission has grounds to believe the affidavit is false. Appropriate voting machines will be provided at the polling places for the casting of ballots on the aforesaid question. Managers of Election will be appointed by the Aiken County Board of Voter Registration and Elections and the Saluda County Board of Voter Registration and Elections. The Managers of Election shall see that each person offering to vote takes the oath that he or she is qualified to vote at this election according to the Constitution of the State of South Carolina and that he or she has not voted previously in this Referendum.

Every person offering to vote (a) must be at least 18 years of age on the date of the Referendum; (b) must reside in the School District; (c) must be duly registered on the books of registration for Aiken County as an elector in the precinct in which he or she resides and offers to vote on or before the date on which said books of registration are closed for the Referendum; and (d) such documents and/or forms of identification as required by State law.

The last day a person may register to be eligible to vote in the Referendum will be April 1, 2018. Online registrations and registrations submitted by email or fax must be received no later than April 1, 2018. Applications for registration to vote sent by mail must be postmarked no later than April 2, 2018. The deadline to appear in person to register to vote at the respective voter registration office is 5:00 p.m. Friday, March 30, 2018. The process of examining the return addressed envelopes containing absentee ballots will begin at 9:00 a.m. on the date of the Referendum in the Aiken County Voter Registration and Elections Office, Aiken County Government Center, 1930 University Parkway, Ste. 1200, Aiken SC, for Aiken County, and in the office in the Saluda County Board of Voter Registration and Elections, 111 Law Range Street, Saluda, South Carolina 29138, for Saluda County.

Voters who are blind, who are otherwise physically handicapped, or who are unable to read or write are entitled to assistance in casting their ballot. This assistance may be given by anyone the voter chooses except his or her employer, an agent of his or her employer, or an officer or agent of his or her union. The Managers of Election must be notified if assistance is needed. Voters who are unable to enter their polling place due to physical handicap or age may vote in the vehicle in which they drove or were driven to the polls. When notified, the Manager will help voters effectuate this curbside voting provision. Registered voters may be eligible to vote by absentee ballot. Residents wishing to vote by absentee ballot should contact the Aiken County Voter Registration and Elections, 803.642.2028 for instructions for Aiken County voters and the Saluda County Board of Voter Registration and Elections, 803.445.4500 for instructions.
